**RULES and REGULATIONS:** A completed application must include a \$125 non-refundable check or money order made to the Lindsay Chamber of Commerce. In addition, all food vendors must include a separate check or money order made to the Lindsay Chamber of Commerce for the amount of \$50 check/ money order as a refundable cleaning deposit. Cleaning deposit will be returned at the end of the day if your area is cleaned as satisfaction.

**SET UP** starts at 6am; all vendors must be set up no later than 8am for inspection by the Tulare County Health Department. Samples must be available and turned in at the front entrance of the Chamber of Commerce office by 11am to be judged. There will be a \$500 for the best menudo, \$500 for best pozole and \$100 for the best decorated booth; to be announced at 5pm.

Vendors are required to provide their own canopy, tables, trash containers and any electric cords needed. Place hot coals in designated containers. Water for food and hand washing must be provided by vendor. The location of your booth will be given to you upon check-in on the morning of the event

**ADVERTISING:** In consideration of the foreign entry, contestants agree to permit the Lindsay Chamber of Commerce/City of Lindsay to use their name and/or picture of themselves or display for publicity, advertising and commercial purposes(

including newspapers, magazines, radio and television ) before, during and after the event, and hereby relinquish any rights to any photos and video tapes taken in connection with this event and give permission to publish, sell or otherwise dispose of said photographs and video tapes.

**OPERATION:** Event management reserves the right to restrict entrants to acceptable behavior during any and all activities. NO SMOKING INSIDE OF BOOTH.
