Vendors are required to provide their own canopy, tables, and chairs. **All ride operators must provide proof of insurance.** No changes of location will be accepted. Setup starts at 8am. All vehicles must be out of the event area by 10am and will not be permitted back until 5pm.

**SELLER'S PERMIT:** Please attach a copy of your seller's permit.

**PRODUCT TYPE:** Vendors must designate what they will be selling. The number of related arts, crafts, games, informational and political booths will be limited. The number and types of booths will be at the discretion of the event chairperson. No drugs, alcohol, or sexually explicit items are to be displayed, sold, or given away. **NO water guns, noise poppers, fireworks, confetti eggs, canned string of any type are allowed.**

**OPERATION:** Management reserves the right to restrict vendor to acceptable behavior and appearance during all activities. In case of eviction, the Lindsay Chamber of Commerce is not liable for returning fees.

**LIABILITY:** In consideration of the acceptance of the right to participate, entrant by execution of this entry form, release and discharges the Lindsay Chamber of Commerce and the City of Lindsay and their officers, directors, employees, agents, representatives and servants and anyone else connected with management or presentation of the Menudo & Pozole Cook-off from any and all known damages, inquires, losses judgment, and or claims from any causes whatsoever that may be suffered by any entrant to his person or property.
